FARMERS' RIGHTS

Challenges, Success Stories and Ways Forward

Farmers' Rights are a cornerstone of the Plant Treaty, as they are a precondition for enabling farmers to maintain and develop crop genetic resources in the fields. The objectives of the Plant Treaty on conservation and sustainable use could not be realized without these rights. Therefore Agenda Item 14 of the Governing Body's 3rd Session – on the implementation of Article 9, Farmers' Rights – is particularly important. A key question is: What steps can the Governing Body take to promote compliance with the treaty provisions on Farmers' Rights? At this side event, we will seek to provide guidance in this regard.

The side event will summarize key challenges as well as success stories from the realization of Farmers' Rights at the national level, based on research from the international Farmers' Rights Project of the Fridtjof Nansen Institute, Norway. It will also draw the lines from the Lusaka informal international consultation process on Farmers' Rights in 2007, via the resolution on Farmers' Rights of the 2nd Session of the Governing Body – with an analysis of the inputs submitted to the Secretariat based on that resolution – and to the 3rd Session of the Governing Body. Along the way, the results from an international expert e-group discussion on options for Farmers' Rights, which was held Nov. 08 – Apr. 09, will be presented, and viable suggestions on next steps for the Governing Body will be derived and discussed.
